

## REDLYNCH PARISH COUNCIL PARISH COUNCIL MEETING MINUTES

Redlynch Parish Councillors met on 14<sup>th</sup> November 2023 for the Ordinary Parish Council Meeting at Redlynch Village Hall starting at 7.00pm.

PRESENT: Cllrs Stride, Newton, and Baker-Beall

**IN ATTENDANCE:** 9 members of the public, Unitary Cllr Zoe Clewer (Wiltshire Council and NFNPA) and Clarissa Cranmer (Parish Clerk).

### **PUBLIC QUESTION TIME**

A member of the public raised several concerns, firstly with regards to R52 he had met with Richard Clewer and was disappointed with regards to his complaint and has agreed to a further appointment in December. Secondly, the footpath to Parish Spring was overgrown, in response Cllr Baker-Beall confirmed that this was cut back last week. Thirdly, the hedge on loosehanger on the left hand side is overgrown and causes traffic to veer into the middle of the road. Forth, was the overhanging hedge at Besomer Drove / Mitchells Corner. They also wanted to raise concerns with regards to the agenda item to discuss the Loosehanger bike trail, and confirmation of the time of the Christmas tree lighting. Lastly, Cllr Newton was addressed with regards to Stockman and Woodlands Charity, concerns were noted.

Nicky Newton advised that she will be unable to attend any more parish meetings and therefore the role of National Parks will need a representative as will the North West quadrant. This will need to be appointed.

### Report from PC Murphy:

- On 18<sup>th</sup> October there was a report of a vehicle obstructing the pavement on APPLETREE ROAD. There have been no further reports or issues reported since so no further action was taken.
- On 19<sup>th</sup> October and 20<sup>th</sup> October there were two further reports of criminal damage reported in CASTLE WOODS which is still being investigated as suspected ball bearing/catapult damage. So far there have been no CCTV results or witnesses however this is all ongoing. Signs have gone up in the close to try and deter any further incidents and neighbours have all been spoken with for safeguarding advice etc.
- On 29<sup>th</sup> October there was anti-social behaviour reported on VALE ROAD this has been dealt with by PCSO MURRAY

  - The ridge works is in hand and the masonry team will hopefully be out at the beginning of the New Year.
  - ii. To discuss any other current issues: Advised Bowers Hill signs were back.
- **23.156 MAINTENANCE –** To approve the works on the report to Lover play area gate and loosehanger fencing.

Members **AGREED** to approve the works.

23.157 WILTSHIRE LOCAL PLAN – Members AGREED to use the body of the comments made from a parishioner who had put together a detailed report that had previously been circulated.

23.158 LOOSEHANGER BIKE JUMPS – The 3 persons supporting this application explained their offer to assist with making safe the bike paths that already exist in the Loosehanger site. It was recommended that we carry this item forward to the next meeting when Cllr Peacock has had a chance to meet and discuss further ascertaining liability and other implications.

Members **AGREED** on this action.

**23.159 LOVER GREEN COMMITTEE** – The Lover Green committee would need to put this in writing to formally request a grant however it was suggested that the Southern Area Board would be a good option to approach for funding.

Members AGREED on this action.

23.160 WASTE COLLECTION – Hills are not able to collect the rubbish as they only provide a wheelie bin , not empty a bin with a black sack. It was suggested that maybe someone from the social club could empty the bin on our behalf , a request to be forwarded to them.
